3 [I] Actuals Update

- Ridgidware is doing fine at the moment

- Scholarships: there are still unclaimed awards from the fall term, as well as 1 yet-to-be-awarded scholarship for this term
- Abdullah to follow up on the details behind the "Yearbook Sale Revenue" line item

• Expenses:

- Cable is a credit because that is how it is noted in the university's ledger
- Casual payroll pays for student staff that work for EngSoc
- Conference includes the money spent on FYIC
- ECIF includes the money paid out this term, but allocated in previous terms. This includes the new front desk as well as the benches outside POETS
- Novelties bought more inventory to sell
- Other general expenses include the \$2000 received from the Dean for Canstruction, which we've now paid out. It also includes mounting car parts in POETS

• C&D:

- Departments haven't catered many events yet from the C&D, which is why that number is low
- Have C&D weekly sales been going down over the last few years? Yes, mainly because classes have been scheduled in E5/E6/MC, which are much further away from the C&D. Class scheduling is not in our control, but we can account for it by adjusting food purchasing accordingly
- We have C&D space in E7, so we should be able to serve more students when that space opens
- Right now, budgeted amounts and actual amounts are significantly different, but the differences should be resolved by the end of the term
- One more spending update to follow at the board meeting in March.
