5.4 [D] ECIF Policy Exception (Appendix C)

- Seconded by Mechatronics 2016
- Mover speaking to the motion:
 - When making the budget for the term, the policy manual states that in the Fall term, 15% of student fees are allocated to ECIF
 - Doesn't make much sense given that Winter terms have an equal number of students on campus since all of the fourth-year students are on campus
 - This motion was put forward to override the by-laws for this term and have 15% of student fees budgeted for ECIF instead of 5% as stated in the by-laws
- Seconder declined to speak to the motion
- What is ECIF?
 - Engineering Capital Improvement Fund. It goes towards paying for POETS upgrades, Orifice upgrades, and other capital upgrades to engineering
- Motion is read
- Does the budget attached to the agenda already include this?
 - Yes, it does
- Where is this money coming from?
 - It comes from budgeted student fees as well as budgeted Orifice sales
- If we didn't pass this motion, where would the money go?

- If this motion did not pass, it would go towards subsidizing other events
- EngSoc is a not-for-profit, so we cannot run a surplus. Instead of ECIF, we'd have to give away free food, but ECIF is a better option in the long run
- Are there currently more rejections for ECIF proposals in the Winter term?
 - It depends on a term-to-term basis some terms we get a lot, some terms we get very few
- Is there a reason we're not amending the policy right now?
 - By-law and policy changes need to be submitted at least a month in advance; we'll take a look at that later
 - Policy manual is binding except when Council passes a motion to exempt the current term from a given policy

 - ESSCO is running an inter-school hockey tournament
 - They asked for transport, entrance fees and hotel, but it's being held in Waterloo so it makes no sense to pay for a hotel
- Why is there money allocated to Mac Eng Musical?
 - Because we're going there in a bus
 - Historically, it's been a very popular event, and carpooling hasn't been a popular option in the past
- Why is the ski trip allocated an extra dollar?
 - It's probably a typo
- Motion to amend the budget to put the extra dollar into a pool, then allocate it to 2016 Spirit, then give 2016 Spirit an additional \$149
 - Mover: Civil 2016
 - Seconder: Mechanical 2016
 - Mover speaks to the motion:
 - * There used to be a spirit budget for every graduating year used to help host events to get more people integrated into EngSoc
 - * The 2016s really need to get involved this year, and we encourage you to put in your own budget line items
 - Seconder declined to speak to the motion
 - Why aren't these items on the budget in the first place?
 - * There weren't enough applications repeatedly; when there were applications, 95% of the applications would be for 'free ice cream' or 'board games in POETS' events
 - * Most events ended up being attended by friends of the organizers rather than the class as a whole
 - Motion for amendment called to question:
 - * 18 opposed
 - * 10 in favour
 - * 3 abstentions (B-Society executive, Software 2020, Software 2018)
 - * The motion fails.
